

## **Berkeley Foundation Resilience Fund**

# **Application form 2021/2022**

The Berkeley Foundation's Resilience Fund is now open to applications.

The Fund aims to support small and grassroots organisations to invest in organisational development and build resilience for the future. It builds on the success and impact of our previous Capacity Building Fund and will distribute grants of up to £30,000 over two years, with c.10 grants to be awarded per year. In its first year, the fund will be focused on organisations working to help young people into employment.

Before you apply, please familiarise yourself with the eligibility criteria and funding guidelines, as we can only fund organisations that meet all eligibility criteria and submit all requested documents.

The Resilience Fund is the only live funding opportunity that the Berkeley Foundation is currently running.

### **Eligibility Criteria**

Your organisation is a registered charity or community interest company (CIC), with an income between £100,000 and £1.5m;

You deliver in Greater London, Berkshire, Buckinghamshire, Hertfordshire, Oxfordshire, Surrey, Kent, Hampshire, West Midlands, West Sussex, Warwickshire or the City of Birmingham;

You need to have at least one year of published accounts.

Your work enables young people, aged 16-25, to overcome barriers to work and kick-start their careers;

You are able to demonstrate a need for investment in organisational capacity and infrastructure;

You have not had Capacity Building support from the Berkeley Foundation before.
